Looking back on the 2024-2025 school year I would be lying to tell you that everything is just fine. Instead, I choose to admire the silver lining of some of our accomplishments. At a national level, public sector workers are seeing their rightfully earned Social Security benefits restored after successfully repealing WEP-GPO in the final hours of the 118th Congress in December. Here in Nevada, as of Friday our Governor has set a new veto record - killing 87 bills passed by the Legislature, however PERS Equity was not one of them. That means that ESPs who work 900 hours during the school year will get a full year of credit toward their PERS benefit (like certified employees have always earned). You can read the details of wins and losses at the state and national levels in email communication directly from NEA and NSEA. Watch for them! Meanwhile, here locally our affiliate recruited 9 new members to WREA and some of them ran for a seat on our Board of Directors! We identified an exceptional candidate as the recipient of the Bernie Anderson

WREA Scholarship and contributed almost \$1K to the NEA PAC Fund for Children and

July's selection is The Borrowed Life of Frederick Fife by Anna Johnston. Frederick was born with an extra helping of kindness in his heart. If he borrowed your car, he'd return it with a full tank of gas. The problem is there's nobody left in Fred's life to borrow from. At 82, he's lonely, broke and on the brink of homelessness. But his luck changes when, in a bizarre case of mistaken identity, he takes the place of grumpy Bernard Greer at the local nursing home. Now he has warm meals and a roof over his head – as long as his poker face stays in better shape than his prostrate and his look-alike never shows up. Denise Simms is stuck breathing the same disappointing air again and again. A middle-aged mom and caregiver at Bernard's facility, her crumbling marriage and daughter's health concerns are suffocating her joy for life. Wounded by her two-faced husband, she vows never to let a man deceive her again. As Fred walks in Bernard's shoes, he leaves a trail of kindness behind him, fueling Denise's suspicions. This is a hilarious, feel-good, clever novel about grief, forgiveness, redemption, and finding family.

A Council of Dolls by Mona Susan Power is August's selection. It is a profoundly moving novel spanning three generations of Yanktonai Dakota women from the nineteenth century to the present day. Sissy, born 1961: Her relationship with her volatile mother is difficult, even dangerous, but her life is filled with beautiful things, including a doll called Ethel. Ethel whispers advice and kindness is Sissy's ear, and in one especially terrifying moment, maybe even saves Sissy's life. Lillian, born 1925: She was born in her ancestral lands in a time of terrible change. Lillian clings to her sister Blanche and her doll, Mae. The sisters are forced to attend an Indian boarding school far from their home and Blanche refuses to be cowed by the school's abusive nuns. But when tragedy strikes, Mae finds her way to defend the girls. Cora, born 1888: Born into the brutal legacy of the "Indian Wars," Cora isn't afraid of the white men who remove her to a school to be "civilized." When teachers burn her beloved beaded buckskin doll, Winona, Cora discovers that the spirit of Winona may not be entirely lost. A Council of Dolls is both quietly devastating yet ultimately hopeful.

June's book is <u>The Lion Women of Tehran</u> and we will be meeting on Tuesday, June 24 to discuss this book.


# **NEA PAC FUND FOR CHILDREN**

# Choosing your account beneficiary Errors can be costly to your heirs

Proper designation and regular review of your retirement account beneficiaries are essential to ensuring that what remains in your account(s) after you pass away goes exactly where you wanted. Improper designation or failure to update account beneficiaries can lead to unnecessary delays, taxes, legal battles, or the money simply not going where you intended.

#### The basics

Always designate both primary and contingent (secondary) beneficiaries. Primary beneficiaries are the first in line to receive your account assets. Contingent beneficiaries will receive your assets in the event that your primary beneficiary(ies) die before you do. If you have multiple beneficiaries, then you should also designate the percentage each beneficiary is to receive.



#### Designating your spouse

For 401(k) and other plans subject to the Employee Retirement Income Security Act (ERISA), a spouse is the automatic sole beneficiary of your account unless your spouse waives his/her right in writing. For IRAs, non-ERISA 403(b) plans, and other retirement plans not subject to ERISA, you may name anyone you wish as your account beneficiary. However, if you live in a community property state, your spouse has a right to 50% of the account assets that were accumulated during the course of your marriage.

#### Designating your children

When designating your children, it's especially important to list them by name and include their Social Security numbers. Keep in mind that if you become divorced, the assets may end up in the hands of the minor child's guardian, which may be your former spouse. In this instance, you may want to name a trustee or custodian rather than the minor child.

#### Keep a list

Use PlanMember's Beneficiary
Summary Report® to create a list of
accounts and registration information
that your heirs will need when you
pass. By law, plan administrators,
custodians, and insurers cannot
disclose the names of your account
beneficiaries to anyone except
you or your beneficiaries, and are
under no obligation to contact your
beneficiaries.

#### Reviewing your beneficiaries

You should review your beneficiaries on a periodic basis and make adjustments as needed. Life events such as marriage, divorce, child birth, or the death of a designated beneficiary can all warrant a change.


