We are entering ELECTION SEASON!

2026 will be a big year for elections including some within our own association. This Spring all of the WREA Officers will be elected in addition to three Directors who serve on the Board. More information will be provided on the Spring elections in the next newsletter issue. However, at this time we are announcing the proposed timeline to elect 5 delegates (plus one alternate in the case of a vacancy) to serve at DA and represent WREA members. The 2026 DA will be held at the Sparks Nugget on April 17-19. Please consider nominating yourself or another member who meets all of the criteria listed here. **Make a mental note to watch for the nomination email message coming to your email box in early January!**

Delegate Assembly Timeline

Nominations open soon for WREA members to serve at NSEA Delegate Assembly. We will elect 5 delegates and 1 alternate to serve in case of an emergency vacancy. The elected will serve a 2-year term representing WREA at Delegate Assembly in Reno/Sparks Nevada on April 17 - 19, 2026. The elected will attend meetings of the Delegate Assembly and be expected to vote on statewide issues presented by NSEA and other matters that come before it.

Nominations will open Monday January 5th and close Monday January 19th. WREA members in good standing may nominate yourself or another member with their expressed permission.

*The bios of the nominated candidates must be received with the nomination form at the WEA offices or emailed to Michele Delano (michelep@prodigy.net) and Bernice Servilican (bcservilican@charter.net) the Election Committee Co-chairs **on or before January 21nd.** **Bios are limited to 75 words.***

The nomination/election process will be held electronically through the assistance of NSEA beginning on Monday January 26th through Friday February 6th. Ballots will be counted on Monday February 9th. All candidates will be informed of the election results as soon as possible and by Friday February 13th. The DA delegates names will also be posted on the WREA website. Please note, in accordance with our Bylaws, if the number of nominees is equal to the number of vacant positions they will be declared elected by acclamation meaning no ballots will be distributed.

Help Fight Truth Decay

Have you found that your trust in the media has eroded? Are you frequently asking yourself if a story is real or fake? Does it seem that bias is creeping into news stories more than ever? If so, you are not alone. Recent national polls by the Gallup organization and the Pew Research Center have shown trust in the media is at near record lows.

It's a concern we share. "We" is a group of local citizens who have banded together to help share some solutions, to provide some tools to help citizens become more savvy consumers of news of all types; traditional news outlets, social media and podcasts. Led by Jody Baden and Steve Mulvenon, our newly formed nonprofit, nonpartisan organization is called the News Literate Community Initiative (NLCI). We like to say we are "Helping Fight Truth Decay."

Drawing on the resources of the national News Literacy Project and other trustworthy sources, we have begun to build a website with a storehouse of tools, tips and techniques to help you tell fact from fiction. Go to www.nlcwashoe.org. There, you'll learn more about us and discover ways to support the initiative and perhaps volunteer. One of our major projects is the development of an Ambassador program where we will train volunteers about media literacy, arm them with a PowerPoint presentation and send them out to a variety of community groups. If that interests you, just email jody@nlcwashoe.org and let her know.

With information coming from thousands of sources—some credible, some misleading—news literacy has become a core civic skill. Being news literate helps people make informed decisions, understand public issues, and engage in meaningful dialogue grounded in shared facts.

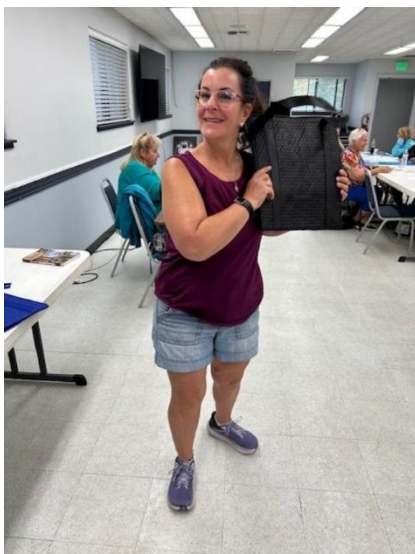

Social Security

Taking early, normal, or delayed benefits

Deciding when to begin taking Social Security is one of the most important retirement decisions you can make. You can start collecting as early as age 62, but your benefits will be reduced by as much as 25% to 30% from what they would be at your "full" retirement age (see the table on the right). Conversely, your benefit is increased by an annual rate of 8% if you delay taking benefits between your full retirement age and age 70.

Sometimes circumstances require people to begin taking benefits as soon as possible. But if you're thinking about retiring early and receive sufficient income from your retirement accounts, a traditional pension plan, and/or other sources, then you can be more flexible about when you begin taking benefits.



Another important factor to consider is your life expectancy. Regardless of when you begin taking benefits, Social Security is designed to pay you the same total amount over the life expectancy of everyone the same age as you. Because almost half of all Americans are expected to live longer than their life expectancies, taking higher, delayed benefits might make sense for you. If you're in good health and your parents lived beyond their life expectancies, then you too might live beyond yours.

Married couples should also consider their ages and health when deciding the time to start taking their personal Social Security benefits, especially if one spouse earned more than the other. Under certain circumstances, the amount of Social Security survivor benefits for a lower-earning spouse could exceed his or her personal benefits. In such a case, the surviving spouse can elect to take the higher survivor benefit. Deciding when to begin Social Security can be quite complex. I would be happy to sit down with you and help determine the best time to start taking your benefits. Ideally this would be before you or your spouse reaches age 62, the age at which you can begin collecting benefits.

Your full retirement age

Your full retirement age is based on your birth year and is the age at which you're eligible to receive full Social Security Benefits.
